

On November 13, 2012, the People's Motion for Entry of Consent Judgment came on for hearing before this Court. After reviewing the papers filed by counsel and hearing argument, the Court ORDERS as follows:

1. Within thirty (30) days of entry of this ORDER, Defendant GIB, LLC (GIB) shall cease all sales of Brazilian Blowout Smoothing Solution (the "Original Product") in or into California.

1 2. With forty-five days of entry of this ORDER, GIB will file and serve a written report
 2 detailing the steps it has undertaken to insure that the Product is no longer being sold in or into
 3 California.

4 3. GIB intends to reformulate the Original Product to meet the requirements of the
 5 Consent Judgment. GIB has submitted confidential ingredient specifications for the reformulated
 6 Original Product to the Attorney General and to CARB, and CARB is now reviewing these
 7 specifications. GIB will also submit two unopened bottles of the reformulated Original Product,
 8 from different product lots, to CARB, for arrival by November 29, 2012.

9 4. By December 11, 2012, CARB will (a) test both bottles using Method 310, to
 10 determine whether they comply with applicable VOC limits, and (b) communicate its results to
 11 GIB through its counsel of record. If CARB confirms that the reformulated Original Product
 12 complies with applicable VOC limits, GIB may sell the reformulated product in and into
 13 California. If the test results indicate that one or both bottles exceed regulated VOC limits, the
 14 parties will meet and confer to discuss the laboratory results and methods and whether a further
 15 reformulation of the product would sufficiently address any problem. If this meet and confer
 16 process is not successful, GIB must cease sales of the reformulated project on the same date that
 17 it is required to cease sales of its Original Product, until it can demonstrate that the product
 18 complies with the 6% allowable regulated VOC limit. The parties will meet and confer to
 19 establish procedures for GIB to make that demonstration.

20 5. Nothing in this ORDER is intended to relieve GIB of its obligation to comply with
 21 any future changes to CARB regulations applicable to the Reformulated Product, including but
 22 not limited to clarifications of CARB's "pump spray" definition so as to make non-spray pump
 23 applicable on the date it offers any Reformulated Product for sale in or into California, including
 24 any VOC limits. Nothing in this ORDER shall be construed as grandfathering an
 25 entitlement for GIB to exceed otherwise-applicable VOC limits on the date it commences
 26 California sales of any Reformulated Product.
